The Mashpee Wampanoag POWWOW Committee is requesting bids for Security for the 2011 Annual POWWOW. The individual/company awarded this bid will provide a minimum of 10 Security team members, on site, at the Mashpee Wampanoag POWWOW grounds for the following hours:

**Security Schedule:**

Friday, July 1 – 12pm, noon – Sat. 9am (4 sec. personnel - This is SET-UP for all vendors)  
Saturday, July 2 – 9am – 9pm (8 - 10 security personnel, 1 is always dedicated to security checkpoint)  
Saturday evening: 9pm - 9am (6 security personnel)  
Sunday, July 3 – 9am – 9pm (8 - 10 security personnel, 1 is always dedicated to security checkpoint)  
Sunday evening: 9pm - 9am (6 security personnel)  
Monday, July 4 – 9am - 6pm (8 security personnel, 1 is always dedicated to security checkpoint)  
Monday evening: 6pm - 9am (4 - 6 security personnel)  
Tuesday, July 5 – 9am – till all vendors have departed (4 security personnel)

**Personnel must:**

- Monitor & be available to assist with any security/medical issues on Tribal grounds
- Monitor/patrol tribal grounds/parking areas for any illicit drug/alcohol use.
- Be available to monitor/patrol tribal grounds for any non-sanctioned activities, paying special attention to non-business hours and camping areas. (2 security persons assigned to camp area at night)
- Be available to escort the Tribal Treasurer/Powwow Committee Treasurer for all money pickups/deliveries throughout the day.
- Provide a written report for any incident requiring action including a brief description of the incident and notation of any outside agency assistance (i.e. Police, Fire or Rescue).
- Have a reliable means of communication (i.e. 2-way radio) of which two (2) are to be provided to the committee designee and Director for each day.
- Be licensed, bonded and have confirmation that all employees have no criminal record.
- Provide a certificate of insurance that includes liability insurance.
- Provide identifiable uniforms for all employees
- Provide one (1) employee to be available and on radio at all times at the pre-determined security checkpoint.
